**WEIGHT RESTRICTION NOTICE**

**CADDIGANS CORNERS - GARDNERVILLE ROAD  
(COUNTY ROAD 62) BRIDGE  
TOWN OF MINISINK  
COUNTY OF ORANGE**

The undersigned Commissioner of Public Works of the County of Orange does hereby restrict the weight of the County Road 62 (Caddigans Corners - Gardnerville Rd.) bridge in the Town of Minisink, Orange County, New York to ten (10) tons.

**SAID BRIDGE** crosses the Rutgers Creek between County Road 62 (Caddigans Corners - Gardnerville Rd.) and the intersection of Gardnerville Road and Carter Road. Said restriction to be effective by the conspicuous posting of "Weight Limit" signs on or about September 16, 2013.

In accordance with the provisions of Section 231 of the Highway Law and the National Manual of Uniform Traffic Control Devices (MUTCD), appropriate traffic control devices will be placed.

Vehicles exceeding the ten (10) ton weight restriction shall use alternate routes.
