ROAD CLOSING NOTICE

**QUARRY ROAD
(COUNTY ROAD 68)
TOWN OF GOSHEN
COUNTY OF ORANGE**

The undersigned Commissioner of Public Works of the County of Orange does hereby close all that portion of County Road 68 (Quarry Road) in the Town of Goshen, Orange County, New York. **BEGINNING** at the intersection of County Road 68 (Quarry Rd.) with the southeasterly right-of-way line of County Road 6 (Pulaski Highway) and runs **THENCE** in a southeasterly direction along said County Road 68 (Quarry Road) approximately 390 feet (0.07 miles) for the purpose of allowing the Orange County Department of Public Works, its agents or contractors, to excavate, repair, pave and do all such work as required in connection with the "Orange Farms Bridge #2 Replacement" on said County Road. Said closing being effective by the conspicuous posting of "Road Closed" signs on or about May 08 2017.

Said county road will be closed to all through traffic for a period of approximately Ninety-one (91) days in accordance with the provisions of Section 104 of the Highway Law. Appropriate traffic control devices, in accordance with the provisions of the National Manual of Uniform Traffic Control Devices (MUTCD), and the New York State Supplement, will be in place and detour routes will be prominently marked. In the case of inclement weather or other unforeseen problems, this period of time may be extended as needed.

Normal through traffic using this portion of County Road 68 (Quarry Road) should use alternate routes or signed detour routing that will utilize County Road 6 (Pulaski Hwy.) and N.Y.S. Route 17A.

Detour Directions for CR. 68 (Quarry Road), Town of Goshen:

Traveling East on County Road 6 (Pulaski Highway):

1. At the intersection of County Road 6 (Pulaski Hwy.) and County Road 68 (Quarry Rd.), continue straight on County Road 6 (Pulaski Hwy.) for approximately 0.5 miles to N.Y.S. Route 17A
2. Turn right onto N.Y.S. Route 17A and proceed southerly for approximately 0.7 miles to the intersection of N.Y.S. Route 17A and County Road 68 (Quarry Rd.)

(End of Detour)

Traveling South on N.Y.S. Route 17A:

1. At the intersection of N.Y.S. Route 17A and County Road 6 (Pulaski Hwy.), continue straight on N.Y.S. Route 17A for approximately 0.7 miles to the intersection of N.Y.S. Route 17A and County Road 68 (Quarry Rd.)

(End of Detour)

Traveling North on N.Y.S. Route 17A:

1. At the intersection of N.Y.S. Route 17A and County Road 68 (Quarry Rd.), continue straight on N.Y.S. Route 17A for approximately 0.7 miles to the intersection of N.Y.S. Route 17A and County Road 6 (Pulaski Hwy.)
2. Turn left onto County Road 6 (Pulaski Hwy.) and proceed westerly for approximately 0.5 miles to the intersection of County Road 6 (Pulaski Hwy.) and County Road 68 (Quarry Road)

(End of Detour)

Traveling East on Jessup Switch Road:

1. At the intersection of Jessup Switch Road and County Road 68 (Quarry Rd.), turn right onto County Road 68 (Quarry Rd.) and proceed southeasterly for approximately 0.6 miles to N.Y.S. Route 17A
2. Turn left onto N.Y.S. Route 17A for approximately 0.7 miles to the intersection of N.Y.S. Route 17A and County Road 6 (Pulaski Hwy.)
3. Turn left onto County Road 6 (Pulaski Hwy.) and proceed westerly for approximately 0.5 miles to the intersection of County Road 6 (Pulaski Hwy.) and County Road 68 (Quarry Road)
