## ATTENTION GUN PERMIT APPLICANTS

All pistol permit applicants are required to take a Handgun Safety Course. The Sheriff's Office has established a list of approved and recommended instructors, **however**, applicants may choose to take training from other sources and submit their training certificates with their gun permit application.

If you choose from the approved and recommended list a common syllabus is taught and a pistol permit applicant may choose any Instructor from the list. The Instructors are divided by geographical area in the county and their fees are listed. Instructors whose fee is marked with an \* indicates that there are additional fees such as mileage, or discounts for multiple students, or private lessons available from that Instructor. Unmarked Instructors means the published fee is the only charge for the course. Pistol Permit Applicants are encouraged to contact the Instructor for a more in-depth review of their fee.
