RE: Creation of additional part-time Campus Security Guard positions

DATE: September 6, 2023

As a result of an agreement between SUNY Orange and CSEA it has been brought to the attention of Orange County Human Resources that additional part-time Campus Security Guard positions will need to be created. Representatives of SUNY Orange advise that ten (10) such positions are being requested by SUNY Orange. The Department of Human Resources therefore refers the matter to the Orange County Legislature authorizing the creation of such positions.

The effect of the creation of such part-time positions will better enable SUNY Orange to maintain the number of Campus Security Guards the college deems warranted to meet the college's needs. The 2023 hourly rate for Campus Security Guards is \$20.9991.
