Commissioners Report – Darcie Miller, Commissioner

- Expansion of housing is a high priority, a meeting is scheduled in July with Commissioner Sullivan. Collaboration conversations with OTDA & OMH, currently spending 75.00 per night for hotel rooms for people.
- In-patient Facility in Town of Wallkill. Plan is to provide detox & inpatient rehabilitation services (which is needed in the Orange County). They want to start with 90 beds and increase to 190.
 - License was approved
 - Location was not approved by town zoning board.
- A local community residence for young adults burned down, they have been relocated to the prior SOCR in Chester.
- Friday July 20, 9:30 11:00 Changing the Eco System in Orange County meeting.
- State Services:
 - ACT State did not communicate to their own staff about the original closure. State staff connected with their union and local legislators. State will keep the seven (7) nine (9) member staff, they currently have 48 slots. The State has committed to hiring additional staff and increase operation to 68 slots. Darcie supported Commissioner Sullivan to increase staff.
 - County will monitor current ACT on timing to open referrals.
 - State Staff will have jobs but we do not have the services required to operate a full ACT team.
 - Forensic Team currently 1 FTE (no increase)

- 3 social workers, 1 peer for forensic services throughout County Court System.
- Lacey Trimble, LCSW has been appointed as the Deputy Commissioner of the Department of Mental Health.

Review of County Plan

Board members reviewed proposed county plan to be submitted to OASAS. It was recommended for two revisions before submission. Regina will make changes and submit. A copy of the final plan will be emailed to board members.

 Motion to approve the County Plan for submission (with the recommended changes/additions) by Jose, second Matt all approved.

Carol L. asked a question w/regard to the form the sub-committees are using for report out to the full CSB. DD workgroup is challenged with the use of the form. Julie Fraino will assist the group.
