## RESOLUTION NO. 3 OF 2019

### RESOLUTION DESIGNATING NEWSPAPERS PUBLISHED WITHIN THE COUNTY AS OFFICIAL NEWSPAPERS FOR THE PUBLICATION OF ALL LOCAL LAWS, NOTICES AND OTHER MATTERS REQUIRED BY LAW TO BE PUBLISHED IN 2019, PURSUANT TO SUBDIVISION 2 OF SECTION 214 OF THE COUNTY LAW.

**WHEREAS**, the County Legislature is required annually to designate at least two newspapers published within the County as official newspapers for the publication of local laws, notices and other matters required by law to be published, and in the making of such designations consideration shall be given to those newspapers advocating the principles of the two major political parties into which the people of the State are divided, and their general circulation throughout the County.

**RESOLVED**, that The Orange County Post published in Vails Gate, New York; the Warwick Advertiser-Photo News, published in Chester, New York; the Warwick Valley Dispatch, published in Warwick, New York; News of the Highlands, Inc., published in Cornwall, New York; Times Community Newspapers, published in Newburgh, New York; and Hudson Valley Press, published in Newburgh, New York are hereby designated as official newspapers for the publication of all local laws, notices and other matters required by law to be published in the year 2019.

**FURTHER RESOLVED**, that nothing herein contained shall be deemed to prevent the designation of additional newspapers for any publication and such designation shall be deemed an official newspaper for that particular publication.
