# CIVILIAN TACTICAL HANDGUN TRAINING



*We're not just going to teach you how to shoot...we'll teach you how to win the gun fight!*

**Concealed Carry with Confidence**



The Orange County Sheriff's Office *Civilian Tactical Handgun Training* (CTHT) prepares law abiding citizens for safe and responsible gun ownership and Concealed Carry.

Students receive hands-on instruction from qualified Firearms Instructors, using lecture style presentations, and Simunition training handguns, all in a comfortable and friendly environment.

The multi-phase training aids citizens new to gun ownership with progression from training handguns to live fire and with development of a personal self-defense plan, incorporating defensive shooting skills, situational awareness, and mental and tactical techniques necessary for survival in real-world hostile encounters.

With the exception of taking the Handgun Safety Course for Pistol Permit Application, the program is not intended for those with Law Enforcement or Military training.



## Training Courses

**Handgun Safety (HS)** Hands-on, non-shooting course covering basic handgun operations, safety, responsible gun ownership, preparation for Concealed Carry, and an overview of NYS Penal Law Article 35. Prerequisite for all other training courses and meets the requirement for Pistol Permit Application. Located at the Sheriff's Office. Cost: \$60



**Fundamentals of Tactical Handgun (FOTH I, II)** Comprehensive two-part shooting course with a focus on safe gun handling and the fundamentals of marksmanship shooting. Training includes repetitive drills, using Simunition and laser handguns, designed to develop and improve accuracy and speed. The student is introduced to shooting from a holster and moving while shooting. Completion of Handgun Safety Course (taken at the Sheriff's Office) required. Located at the Sheriff's Office. Cost: \$85

**Tactical Mindset (TM)** Combined classroom presentation and shooting course with focus on development of a personal self-defense plan. Training includes drills designed for improved defensive shooting skills using Simunition training handguns. Completion of FOTH I & II required. Located at the Sheriff's Office. Cost: FOTH I \$85 , FOTH II \$65

**Tactical Decision Making (TDM)** One-on-one reality based scenario training preparing civilians for real world encounters, using Simunition training handguns. Completion of TM required. TAC House, 85 6 1/2 Station Rd, Goshen. Cost: \$75

**Fundamentals of Tactical Handgun LIVE** Live-fire training in a small group setting reinforcing skills learned through out the CTHT program. Pistol Permit required. Completion of FOTH II required. Located at the Tactical Training Facility, Rt. 17M, New Hampton. Cost: \$75

**Use of Force (UOF)** An in-depth look at the elements of NYS Penal Law Article 35 related to the use of Deadly Physical Force. UOF is designed to encourage class discussion. UOF may be taken at any time after completion of the Handgun Safety Course (taken at the Sheriff's Office). The class is located at the Sheriff's Office. **No charge.**
