Whenever a paper or document, presented to a County Clerk for filing or recording is not legible or otherwise suitable for scanning or recording by the process, the County Clerk may require a legible or suitable copy thereof along with such paper or document, and the same fees shall be payable for the copy as are payable for the paper or document.
