ROAD CLOSING NOTICE

**SARAH WELLS TRAIL
(COUNTY ROAD No. 8)
TOWN OF HAMPTONBURGH
COUNTY OF ORANGE**

The undersigned Commissioner of Public Works of the County of Orange does hereby close all that portion of County Road No. 8 (Sarah Wells Trail) in the Town of Hamptonburgh, Orange County, New York. **BEGINNING** at a point approximately 1,750 feet northeast of the intersection of County Road No. 8 (Sarah Wells Trail) and Kipp Road and runs **THENCE** in a northeasterly direction along said County Road No. 8 (Sarah Wells Trail) approximately 500 feet (0.1 miles) for the purpose of allowing the Orange County Department of Public Works, its agents or contractors, to excavate, repair, pave and do all such work as required in connection with the "Bridge Maintenance of Kipp Station Bridge" on said County Road. Said closing being effective by the conspicuous posting of "Road Closed" signs on or about August 23rd, 2021.

Said county road will be closed to all through traffic for a period of approximately Seven (7) days in accordance with the provisions of Section 104 of the Highway Law. Appropriate traffic control devices, in accordance with the provisions of the National Manual of Uniform Traffic Control Devices (MUTCD), and the New York State Supplement, will be in place and detour routes will be prominently marked. In the case of inclement weather or other unforeseen problems, this period of time may be extended as needed.

Normal through traffic using this portion of County Road No. 8 (Sarah Wells Trail) should use alternate routes or signed detour routing that will utilize N.Y.S Route 207 and County Road No. 77 (Egbertson Road).

Detour Directions for CR. 8 (Sarah Wells Trail), Town of Hamptonburgh:

Traveling Northeast on N.Y.S. Route 207:

1. At the intersection of N.Y.S. Route 207 and County Road No. 8 (Sarah Wells Trail), continue straight on N.Y.S. Route 207 proceed northeasterly for approximately 3.3 miles to the intersection of N.Y.S. Route 207 and County Road No. 77 (Egbertson Road)
2. Turn right onto County Road No. 77 (Egbertson Road) and proceed southeasterly for approximately 1.8 miles to the intersection of County Road No. 77 (Egbertson Road) and County Road No. 8 (Sarah Wells Trail)

(End of Detour)

Traveling Southwest on County Road 8 (Sarah Wells Trail):

1. At the intersection of County Road No. 8 (Sarah Wells Trail) and County Road No. 77 (Egbertson Road), turn right onto County Road No. 77 (Egbertson Road) and proceed northwesterly for approximately 1.8 miles to the intersection of County Road No. 77 (Egbertson Road) and N.Y.S. Route 207
2. Turn left onto N.Y.S. Route 207 and proceed southwesterly for approximately 3.3 miles to the intersection of N.Y.S. Route 207 and County Road No. 8 (Sarah Wells Trail)

(End of Detour)

Traveling Northwest on County Road 51 (Hulsetown Road):

1. At the intersection of County Road 51(Hulsetown Rd.) and County Road No. 8 (Sarah Wells Trail), turn left onto County Road 8 (Sarah Wells Trail) and proceed southwesterly for approximately 100 feet to the intersection of County Road 8 (Sarah Wells Trail) and County Road No. 77 (Egbertson Road)
2. Turn right onto County Road No. 77 (Egbertson Road) and proceed northwesterly for approximately 1.8 miles to the intersection of County Road No. 77 (Egbertson Road) and N.Y.S. Route 207
3. Turn left onto N.Y.S. Route 207 and proceed southwesterly for approximately 3.3 miles to the intersection of N.Y.S. Route 207 and County Road No. 8 (Sarah Wells Trail)
