See attached map. These lands north of NYS Route 17 are proposed under the new Town of Palm Tree. This division and the proposed new Town has been made by petition of qualified electors of the Town of Monroe, County of Orange under NYS Town Law Article 5. The petition seeks County Legislature determination to grant the petition and provide for the submission of the proposition to the electors of the Town of Monroe. This action seeks to divide these lands into two (2) Towns to separate governmental affairs and functions. The Petition does not involve any physical or site disturbance; however, the impacts of potential development at buildout are included within the scope of this action. This review focuses on the grant of petition, the submission to the electors, and 56+/- acres within proposed Town but outside of current Village.
