

2018 Shared Services Panel Tentative Timeline:

Thursday, April 19, 1:30 pm	Shared Services Panel Meeting - OC Emergency Services Center, Goshen
Thursday, May 17, 1:30 pm	Shared Services Panel Meeting - OC Emergency Services Center, Goshen
Thursday, June 21, 1:30 pm	Shared Services Panel Meeting - OC Emergency Services Center, Goshen

By August 1, 2018	County Executive submits Shared Services Plan to the County Legislature
August 2, 2018	Legislature meets
By August 30, 2018 (TBD During July and August)	Three Public Hearings - The county CEO, the county legislative body and a panel shall accept input from the public, civic, business, labor and community leaders on any proposed plan. The county CEO shall cause to be conducted a minimum of three public hearings prior to submission of a plan to a vote of a panel. All such public hearings shall be conducted within the county, and public notice of all such hearings shall be provided at least one week prior in the manner prescribed in public officers law. Civic, business, labor, and community leaders, as well as members of the public, shall be permitted to provide public testimony at any such hearings.
September 6, 2018	Legislature meets- on agenda? By September 15, 2018 the Legislature shall “review and consider the county-wide Shared Services Plan” and may by majority vote issue an “advisory report” making recommendations as deemed necessary.
September 7, 2018	The County Executive may modify the Shared Services Plan based upon such recommendations prior to the submission of the Plan to the Shared Services Panel. County Executive sends modified final plan to the Panel for their review.
September 13, 2018 *** Panel will Vote on Plan***	Shared Services Panel Meeting and approval/disapproval of Shared Services Plan - Orange County Emergency Services Center, Classroom 1, 22 Wells Farm Road, Goshen. A majority vote is required to vote on the plan. Each Panel Member must state in writing the reason for his or her vote. Each member of the Panel may remove any proposed action that affects their local government. Written notice of the removal will be provided to the CEO prior to the Panel-wide vote.
Before September 15, 2018	Panel must meet to vote (disapprove, modify or approve) on the plan.
If the Plan Fails or is not Voted on by September 15, 2018:	The CEO must release a report to the public on why the Shared Services Plan was not approved or acted upon within the County. The report must include the vote of the Panel, and the written justification that each Panel Member provided to the CEO for the Member’s vote must be attached to the report.
By September 15, 2018	The County Executive will submit the plan to the NYS Director of the Division of Budget
By October 15, 2018	County Executive will disseminate and present the plan to the public
