NOTICE IS HEREBY GIVEN, that the Orange County Legislature and members of the Department of Planning of the County of Orange, New York, will meet at the Legislative Chambers At the Orange County Government Center located at 255 Main Street, Goshen, New York on Thursday, the 7th day of June 2018 beginning at 3:15 p.m. (EDST) for the purpose of holding a public hearing and to solicit comments and concerns from the public with respect to the proposed modifications on Agricultural Districts Nos. 1 and 2. Orange County Agricultural District No. 1 is located to the northeast of NYS Route 17 and encompasses all or parts of the Towns of Blooming Grove, Chester, Cornwall, Crawford, Goshen, Hamptonburgh, Monroe, Montgomery, Newburgh, New Windsor, Wallkill and Woodbury. Agricultural District No. 2 is located southwest of NYS Route 17 and encompasses all or part of the Towns of Chester, Deerpark, Greenville, Goshen, Minisink, Monroe, Mount Hope, Wallkill, Warwick and Wawayanda.
